**UPON THE APPLICATION** of:

Alan Robert Bloom, Alan Michael Hudson and Stephen John Harris of Ernst & Young LLP, the joint administrators of the Company (together, the "**Joint Administrators**")

**AND UPON READING** the eighth witness statement of Stephen John Harris dated 8 August 2018 and the exhibits thereto and the letter from Hogan Lovells International LLP ("**Hogan Lovells**") dated 22 August 2018 on behalf of the Trustee of the Nortel Networks UK Pension Plan (the "**Trustee**")

**AND UPON HEARING** Charlotte Cooke for the Joint Administrators and Matthew Bullen of Hogan Lovells for the Trustee

**IT IS ORDERED THAT:**

- (1) the appointment of the Joint Administrators shall cease to have effect pursuant to paragraph 79(1) of Schedule B1 to the Insolvency Act 1986 (the "**Act**") with effect from the passing of the resolution by Nortel Networks AB (in administration) to wind up the Company voluntarily in accordance with Finnish law;
- (2) the Joint Administrators of the Company be discharged from liability pursuant to paragraph 98 of Schedule B1 to the Act with effect from 28 days after the date on which their appointment has been terminated in the manner set out at paragraph 1 above;
- (3) if the relevant step required to wind-up the Company as referred to in paragraph 1 above is not completed within 45 days of the date of this Order, the matter be re-listed for hearing within 14 days; and
- (4) the costs of and incidental to the Application be paid as expenses of the administration of the Company.
